2020 Series Regulations: **Historic Touring Car Challenge**

The Motor Racing Legends Historic Touring Car Challenge is a series of invitation races for Touring Cars that competed during the period 1966 to 1990 inclusive. Specific requirements are covered under 'Eligibility' below. The Historic Sports Car Club will be the organising club.

There will be four rounds of the HTCC in 2020:

August 15 th – 16 th	Thruxton Historic	2 x 40 minutes
October 25 th	Silverstone Historic TT	60 minutes

Historic Touring Car Challenge and Tony Dron Trophy cars will also have a dedicated race in Portugal:

November 6 th - 8 th	Algarve Classic Festival	2 x 40 minutes

It is a requirement of entry that all drivers and co-drivers must be fully paid up members of the Motor Racing Legends Club. A single-race membership is available.

Race Detail

Each race will be for two (or exceptionally one) driver entries, open strictly by the invitation of Motor Racing Legends, to drivers of all nationalities holding a minimum of a Race National or Race International D race licence. For UK races, a minimum of a Race Interclub will be acceptable. Exact details will be given in the SRs for each meeting. The owner of the car must drive for at least 50% of the racing duration.

Each race will feature a compulsory pit stop and driver change where relevant. The car must be at rest for a minimum of 60 seconds during the pit stop. A solo driver can remain in the car during the pit stop. Any car failing to make a pit stop will be excluded from the results. Any car failing to make a pit stop within the pit window will incur a Drive-Through penalty.

The starting grid for each race, or for race 1 in a double-header race will be made up according to the best times achieved during qualifying. In a double-header race the starting grid for race 2 will be derived from the finishing results from race 1. Race starts will be rolling starts. For double-headers, awards will be based on the combined results of both races.

Attendance at briefings by drivers is mandatory and the organisers must be notified if a driver is unable to attend a briefing due to a schedule clash.

Eligibility

The Historic Touring Car Challenge is open to Touring Cars homologated within the following periods:

Group A	from 1 st January 1986 to 31 st December 1990
Group A	from 1 st January 1982 to 31 st December 1985
Group 2	from 1 st January 1970 to 31 st December 1981
Group 5	from 1 st January 1966 to 31 st December 1969

All cars must conform to the relevant sections Appendix 'J' of the International Sporting Code of the period; and to technical requirements of the current Appendix 'K' of the International Sporting Code. Cars complying with other national regulations will be considered providing they comply with the correct period regulations for either the BTCC or ETCC.

Each car should have a valid, current FIA Historic Technical Passport (HTP), a copy of which is to be submitted with the entry form for the series. For 2020, cars without a current valid HTP will be considered provided they comply with the above eligibility requirements.

All cars must have a valid, signed 'MRL Engine Capacity Certificate' certifying the bore, stroke and valve sizes for the engine. Entries accepted without an Engine Capacity Certificate will be classified as Invitation and will not qualify for podium places or class awards.

Group A cars built prior to 1986 may be permitted to run components homologated during 1986 by prior agreement with the organisers.

The organisers reserve the right to impose a Balance of Power that may include a turbo charger restrictor and/or rev limiter to specific models, or individual competitors in order to preserve performance parity.

- Scrutineers: Chief Eligibility Scrutineer – John Hopwood; Assistant Eligibility Scrutineer – Don Hands.
- Tyres: Cars must run tyres from either Goodyear or Dunlop ranges in slick/dry conditions. In wet conditions tyre choice is free. In all cases tyres must be in accordance with Appendix K. The sole nominated tyre supplier & service provider for the series is HP Tyres. An HP Tyres order form is appended to the Race Series Entry Form.
- Fuel: Competitors are advised to read FIA Appendix 'K' Cl. 3.9 regarding fuel specification. This regulation will be enforced.
- Sponsors' Decals: Race numbers & roundels will be provided. It is a condition of entry that sponsors' decals, where provided, must be applied in the approved location.
- In-Car Cameras: If fitted, no such camera may project outside the bodywork or be mounted on the outside of a roll cage. All such cameras must be installed prior to scrutineering where they will be checked for location and security.
- Two-Driver Entries: Where two or more drivers have set a qualifying time in a specific car both drivers must then drive that car in the race, unless previously agreed with Motor Racing Legends. Failure to do so may result in a penalty being applied.
- Re-fuelling: Re-fuelling is not allowed under any circumstance during qualifying or race.
- Silencing: Maximum permitted noise levels are not defined in these series regulations. However, some circuits/venue owners/meeting organisers may impose restrictions in the Supplementary Regulations. Motor Racing Legends will give as much advanced warning as possible of the need for cars to comply with any noise restriction.

Awards

Awards for first, second and third place overall will be presented on the podium immediately following the race. In addition, Motor Racing Legends will present awards for each Class winner, plus awards for 2nd and 3rd in class subject to entries received. For double-headers, awards will only be given for the combined results of both races.

Classes

Class results for each race will be derived from the overall finishing positions. Cars will be divided into separate classes as follows:

Class HT3	Cars complying with Group A regulations up to Dec 31 st 1985
Class HT4	Cars complying with Group A regulations up to Dec 31 st 1990

Each Period will be further divided by capacity as follows:

Sub-class A	Cars with capacity not exceeding 1600cc
Sub-class B	Cars with capacity not exceeding 2500cc
Sub-class C	Cars with capacity exceeding 2500cc

For the purposes of classification:

Turbo charged cars constructed prior to 1988 will have a co-efficient of 1.4 applied to their capacity.

Turbo charged cars constructed from 1 January 1988 onwards will have a co-efficient of 1.7 applied to their capacity.

Motor Racing Legends reserves the right to revise, delete or amalgamate any of the above classes, or introduce additional classes according to the entries received, or to introduce an Invitation Class.

Entry Fee

The entry fee (per car) for each race is as noted on the Historic Touring Car Challenge Official Entry Form for the 2020 season and must be paid in full at the time of submission. Preference will be given to those entering all races and single race entries may not be confirmed until four weeks prior to the event. Entries open on publication of these regulations. Entry fees must be paid at least 21 days prior to an event. Entries will not be accepted until payment has been received in full. Once an entry has been accepted, a refund will only be given at Motor Racing Legends' discretion, and provided notice is received in writing at least 21 days prior to the event. If a refund is issued a £50 administration fee will be deducted. Entries will close once all places on each respective grid are filled.

Applications for Entry

All entrants, driver and co-drivers must be fully paid up members of the Motor Racing Legends Club prior to submitting an entry form. A single event membership is available but anyone participating in more than one event must be a full member. All those wishing to participate in the Historic Touring Car Challenge should apply in writing or by using the online application process, on the HISTORIC TOURING CAR CHALLENGE OFFICIAL ENTRY FORM 2020 and submitted with the total entry fee to: -

Motor Racing Legends will formally acknowledge receipt of entries. Acknowledgement of receipt of entry will not imply acceptance for any race. Acceptance will be notified for each race at the earliest opportunity.

As a condition of entry, all entrants accept that their name, that of the nominated driver(s), along with details of the entered car will be shared by the grid organiser with both the event organisers and the race organisers for the necessary management of the racing and for inclusion in event entry lists and results information made publicly available.
